3. VERTIGO - DESCRIPTION

In conducting an assessment of their physical and psychological condition and subsequent ability to safely complete VERTIGO, medical practitioners should be aware that VERTIGO involves the following:

- duration of approximately 90 minutes;
- the pace of the walk is leisurely, however it does involve moderate physical exertion, at heights of up to approximately 42 metres, for periods of up to 60 minutes;
- outdoor walking and climbing unassisted for approximately 500 metres along industrial style walkways and on a roof viewing platform;
- wearing a range of supplied equipment, including a jumpsuit and security harness that weighs approximately 3kg kilograms;
- being harnessed and physically tethered to a continuous rail structure;
- negotiating a 10-metre aerial platform, whilst 42 metres in the air with no handrails;
- VERTIGO is primarily outdoors, and therefore individuals will be exposed to the prevailing weather conditions and must consider their ability to withstand exposure to sun, wind, heat and cold, save that VERTIGO will not take place during inclement weather (rain, high winds, lightning, extreme temperatures); and
- there will be periodic rest stops during VERTIGO, however individuals will need to be physically capable of remaining standing for the duration of VERTIGO and will not have access to toilets, shade, water or seating at all times during VERTIGO.
